

The Conditions of the joint Promotional Event "Give crypto, get crypto"

1. The Organizers of the joint Promotional Event "Give crypto, get crypto" (hereinafter referred to as – "the Promotional Event").

The Organizers of the Promotional Event are:

Currency Com Bel LLC, a limited liability company incorporated in the Republic of Belarus under company number 193130368, with its registered address at 220030, Minsk city, Internatsionalnaya str., 36-1, office 724, room 2, ("**Organizer 1**"), and

Currency Com Global LLC, a limited liability company registered in St. Vincent and the Grenadines under company number 1291 LLC 2021, with its registered address at First Floor, First St. Vincent Bank Ltd Building, James Street, Kingstown, St. Vincent and the Grenadines ("**Organizer 2**"), collectively referred to as the "**Organizers**", and separately - an "**Organizer**"

2. Purpose of the Promotional Event.

2.1. The purpose of the Promotional Event is to stimulate long-term use of the Currency.com proprietary trading platform and the mobile application "Currency.com Exchange" (together referred to as the "**Platform**") by the clients of the Organizers and increase their loyalty.

2.2. The Promotional Event does not constitute a lottery, raffle or any other game of chance. The Promotional Event is carried out by the Organizers and at their own cost.

3. The start and end dates of the Promotional Event.

3.1. The Promotional Event starts on December 3, 2021.

3.2. The Promotional Event ends January 31, 2022.

3.3. The Organizers have the right to terminate the Promotional Event before the end date at their sole and absolute discretion. The Organizers decision on the termination of the Promotional Event before the end date does not apply to participants who have met its conditions before the end of the Promotional Event.

3.4. The Organizers have the right to extend the duration of the Promotional Event at their sole and absolute discretion for any period of time.

4. Conditions under which a person becomes a participant in the Promotional Event.

4.1. The participant of the Promotional Event needs to create an account on the Platform, complete identity verification and become a verified client of either Organizer ("**Inviting Client**").

4.2. Unless expressly provided otherwise, the Promotional Event is held among natural persons that are eligible for using the Platform in accordance with Section 4 of the Terms of Use of the Platform.

4.3. Invited Persons (as defined below) must be new to the Platform. i.e., do not have existing account(s) on the Platform.

4.4. Clients of the Organizers who have participated in the Promotional Event "Welcome Bonus" held by the Organizers are not eligible for participation in this Promotional Event.

4.5. Clients of the Organizers must comply with these Conditions of the Promotional Event, use the rights granted them hereunder to participate in the Promotional Event in good faith, based on the objectives of the Promotional Event and not to abuse these Conditions and the right to participate in the Promotional Event.

4.6. Clients of the Organizers take part in the Promotional Event at their own will and at their own discretion without any assignment from the Organizers.

5. Conditions of the Promotional Event.

5.1. The Organizers shall provide each Inviting Client with unique referral links through their accounts on the Platform. These links are designated for sharing by Inviting Clients with invitees - natural persons who do not have an account on the Platform.

Whenever any person creates an account on the Platform using the link provided by the Inviting Client, such person shall be qualified as referred by the Inviting Client (“**Invited Person**”).

The Inviting Client and Invited Persons receive bonuses provided the following conditions are met:

5.2.1. The bonus shall be credited to the Inviting Client by the Organizer 1 if the following conditions are met:

- The Inviting Client must maintain a verified account with the Organizer 1 and make at least one (1) trade transaction on the Platform;
- The Inviting Client shall share referrals link only with those persons who do not have an account on the Platform;
- The Invited Person must create an account on the Platform for the first time (be a new client) and get it verified;
- The Invited Person must fund their account and make at least one (1) transaction on the Platform within 30 days after the account was created.

If the above conditions are met, the Inviting Client receives the following bonus: USD.cx tokens, which total value does not exceed 100 USD.cx (USD.cx is a token representing currency - US dollars, created and placed by the Organizer 1).

5.2.2. The bonus shall be credited to the Inviting Client by the Organizer 2 if the following conditions are met:

- The Inviting Client must maintain a verified account with the Organizer 2 and make at least one (1) trade transaction on the Platform;
- The Inviting Client shall share referral links only with those persons who do not have an account on the Platform;
- The Invited Person must create an account on the Platform for the first time (be a new client) and get it verified;
- The Invited Person must fund their account and make at least one (1) trade transaction on the Platform within 30 days after the account was created.

If the above conditions are met, the Inviting Client receives the following bonus: USD.cxc tokens, which total value does not exceed 100 USD.cxc (USD.cxc is a token representing currency - US dollars, created and placed by the Organizer 2).

5.2.3. The bonus shall be credited to the Invited Person by the Organizer 1 if the following conditions are met:

- The Invited Person shall use a referral link shared by the Inviting Client when creating an account on the Platform;
- The Invited Person shall not have an existing account on the Platform by the time such a person creates a new account using a referral link and have to become a client of Organizer 1;
- The Invited Person must fund their account and make at least one (1) trade transaction on the Platform within 30 days after the account was created.

If the above conditions are met, the relevant Invited Person receives the following bonus: USD.cx tokens, which total value does not exceed 100 USD.cx (USD.cx is a token representing currency - US dollars, created and placed by the Organizer 1).

5.2.4. The bonus shall be credited to the Invited Person by the Organizer 2 if the following conditions are met:

- The Invited Person shall use a referral link shared by the Inviting Client when creating an account on the Platform;

- The Invited Person shall not have an existing account on the Platform by the time such a person creates a new account using a referral link and have to become a client of Organizer 2;

- The Invited Person must fund their account and make at least one (1) trade transaction on the Platform within 30 days after the account was created.

If the above conditions are met, the relevant Invited Person receives the following bonus: USD.cx tokens, which total value does not exceed 100 USD.cxc (USD.cxc is a token representing currency - US dollars, created and placed by the Organizer 2).

5.3. The Organizers have the right not to credit a bonus to Invited Persons or Inviting Clients who are not clients of the respective Organizer.

5.4. When sharing the referral links the Inviting Clients shall comply with the legislation of the Republic of Belarus on advertising and the acts of the Supervisory Council of the High Technologies Park (the Republic of Belarus) as well as with the legislation of the jurisdiction where referral links are shared.

6. Bonuses for meeting the conditions of the Promotional Event.

6.1. The Inviting Clients and Invited Persons who have met the conditions of the Promotional Event (Section 5 hereof), shall receive the following bonus: USD.cx tokens, which total value does not exceed 100 USD.cx (100 USD.cxc) (USD.cx is a token representing currency - US dollars, created and placed by the Organizer 1; 100 USD.cxc is a token representing currency - US dollars, created and placed by the Organizer 1).

For the purposes of these Conditions, the term “bonus” means transferring by correspondent Organizer the title of property to tokens on a free-of-charge and non-refundable basis to the Inviting Client and Invited Persons in accordance with this Section 6.

6.2. The title of property to tokens stipulated herein shall be transferred by the Organizers by crediting the relevant quantity of tokens to client’s accounts on the Platform.

7. Other conditions of the Promotional Event.

7.1. The price (value) of tokens (including for the purpose of expressing the price (value) of tokens of one type in prices (value) of tokens of another type) shall be determined by the Organizers at its sole and absolute discretion.

7.2. If, in accordance with the legislation, the Organizers are obliged, with regard to obtaining by the client under this Conditions income, to deduct and transfer to the state budget a tax, the relevant income shall be transferred to the client after deducting such a tax (i.e. minus the sum of the relevant tax).

7.3. These Conditions may be amended or terminated, and the Promotional Event may be terminated (extended) at any time by the Organizers at their sole and absolute discretion.

7.4. The client must comply with these Conditions of the Promotional Event, use the rights granted hereunder in good faith, based on the objectives of the Promotional Event and not to abuse these Conditions and the right to participate in the Promotional Event.

The Organizers have the right to bar the client from participation in the Promotional Event or to suspend participation of the client in the Promotional Event if the client abuses the terms of the Promotional Event. Abuse of the terms of the Promotional Event means the performance by the client of actions that, according to the subjective opinion of the Organizers, do not have a reasonable meaning, contradict the objectives of the promotion and entail the receipt by the client of unreasonable benefits based primarily on the technical and / or organizational features and / or conditions of the Promotional Event.
